



NAIZIL PVC COATED FABRICS: WARRANTIES

Subject to the terms hereof, Naizil S.p.A. warrants its Naizil coated fabrics to be in accordance with the Naizil's published technical specifications and free from material defects in components and workmanship affecting performance and durability at the time of the delivery and for the period of time and percentages hereinafter detailed.

Full technical data sheets of all Naizil coated fabrics are issued by Naizil S.p.A. and can be requested by the client in any moment.

Naizil acknowledges that the warranty is limited to the repair or replacement of any damaged part. Such parts that might require repairing or replacement are quantified as the original cost of the coated fabric supplied, according to the percentage valid for the year in which the event occurs, plus a sum of equal value as compensation for the working and repairing of the fabric cover.

WARRANTY LIMITATIONS

This warranty applies if the fabric becomes unserviceable due to untimely deterioration under normal conditions of exposure and use.

This warranty is void if the fabric is subject to improper use, misuse, abuse, improper manufacturing and exposure to chemical substances that are in concentration or of nature different from those that may be found under normal weathering conditions.

The file "*Maintenance, cleaning and storage of the pvc coated fabrics*", here attached, is an integral part of this Warranty.

This Warranty is void if the fabric is not constantly subject to an accurate cleaning as it is indicated on the file "*Maintenance, cleaning and storage of the pvc coated fabrics*"

This operation is necessary in order to avoid that organic or inorganic material, that normally tends to settle on the surface over the time, is absorbed by the surface, otherwise any remedy would be of no avail.

On the double membrane structures, this Warranty is valid only if the double membrane structures are solely manufactured with Naizil fabrics.

If other fabrics –not Naizil– are used together, this warranty will be void.



CLAIMS

Claims under this warranty shall be valid only if made in writing to Naizil S.p.A. (Campodarsego, Italia) by registered letter or by PEC, and enclosing a copy of the original purchase invoice of the fabric with any further details that might be helpful to the tracking procedure, within and not over 30 (thirty) days following the date upon which the fabric was first considered by the customer to be subject to a warranty claim.

If the notice of claim is not sent or is sent late, this shall cause the guarantee to be void and therefore devoid of legal effect with respect with the defect found. On receiving the notice, Naizil S.p.A. reserves the right to inspect the membrane structure to verify the defect and to find a solution to the problem. If the right to inspection is denied, the guarantee shall be void and devoid of legal effect.

In no event Naizil S.p.A. shall be liable for any loss of profit, of use of equipment or capital and of the direct or indirect damages consequential to the main damage of any nature resulting from or in any manner relating to the fabric.

The foregoing constitutes the sole warranty offered by Naizil S.p.A. with respect to the Naizil coated fabrics named in this warranty.

All legal disputes shall be solved by the Court of Padua (Italy), hereby recognised as the sole Court of competent jurisdiction.

EFFECTIVENESS OF GUARANTEE


This limited guarantee shall become effective after written communication of the following information to our address of:


- CUSTOMER
- NAIZIL COATED FABRIC USED and QUANTITY
- PROJECT LOCATION
- PROJECT DESCRIPTION
- ACTUAL DATE OF COMPLETION ON SITE


In addition, this guarantee shall be considered effective only for the Naizil coated fabrics listed here for conversion into air-inflated, frame supported and tensioned architectural membrane structures that have been designed and certified by a chartered engineer.
