



## TWO YEAR Limited Warranty

STRATAGLASS Composite Marine Sheets are guaranteed for a period of two (2) years from the original date of manufacture against defects found upon inspection, during fabrication or during marine enclosure use.

In the unlikely event of a STRATAGLASS failure during the two (2) year period, we will supply you, the original owner or provider, with replacement STRATAGLASS marine sheets at no charge providing the following conditions are met:

- 1) The owner or provider must [register](#) the purchase online and obtain a Warranty Registration Number to verify proof of purchase. This Warranty Registration Number must be provided to process a warranty claim.
- 2) The owner or provider must properly clean and maintain the Strataglass product during use according to manufacturer's instructions.
- 3) The owner or provider must return defective sheets or representative samples of the defect to the manufacture for inspection, testing and warranty validation.

Warranty validation will be at the sole discretion of STRATAGLASS LLC. All warranty claims will be considered on an individual basis. This warranty does not cover labor or any additional costs associated with the replacement.

STRATAGLASS must be properly cleaned and maintained using only authorized cleaning products and methods. Care and maintenance instructions are provided on the Care and Maintenance Data Sheet or can be found on the STRATAGLASS Website: [www.strataglass.com/strataglass-care-and-maintenance](http://www.strataglass.com/strataglass-care-and-maintenance) Failure to properly clean and maintain your STRATAGLASS enclosure panels will void your warranty.

Please register your purchase of Strataglass within thirty (30) days of final installation by registering online at [www.strataglass.com/registration](http://www.strataglass.com/registration). You must provide proof of purchase and obtain/retain a Warranty Registration Number.

This Limited Warranty is subject to the following:

- This Limited Warranty only applies to properly maintained STRATAGLASS Marine Sheets, which have been registered online at [www.strataglass.com/registration](http://www.strataglass.com/registration). Under no circumstances, at any time will STRATAGLASS be liable for labor or additional costs other than the STRATAGLASS sheet itself
- This Limited Warranty does not apply to any product or any part thereof that, in the sole judgement of STRATAGLASS LLC, have been subjected to misuse, alteration, aggressive cleaning, aggressive detergents, accidental damage to the surface, Acts of God, abused by

machinery, excess wear and tear, abnormal weather conditions, exposure to harmful chemicals, falling objects, friction, explosion, fire, flood, riots, civil commotion, drones, neglect, scratches, perforations, damaged during handling or fabrication, subjected to unusual atmospheric pollution, Is used or fabricated in a manner inconsistent with recommended care and maintenance instructions of STRATAGLASS LLC. This includes but is not limited to handling and stacking of sheets, exposure to certain fluids, and chemicals or cleaners not approved by STRATAGLASS. Or becomes defective as a result of failure(s) of related products for which STRATAGLASS LLC. Is not responsible.

- This limited warranty is the exclusive warranty with respect to the products, is in lieu of, and supersedes all other representation or warranties, whether written or oral, express or implied. STRATAGLASS LLC. Expressly disclaims any implied warranties of merchantability of fitness for a particular purpose. The sole and exclusive remedies of any person relating to the products and the full liability of STRATAGLASS LLC. for any breach of this warranty are those provided in this limited warranty and user of the products hereby agrees and acknowledges that no other warranties are offered or provided in connection with or for the products or any part thereof.
